I. Call to Order

Director Turner called the meeting to order at 7:05 pm.

Director Turner informed the Commission that generally, at the first Commission Meeting of the year, the elections of a Chair and Vice-Chair take place. She stated that the current Commissioners can elect a Chair and Vice-Chair this evening, or at the March Commission Meeting after the District Council appointment of three new Commissioners.

A discussion was held and it was agreed that Item II. on the agenda, "Election of Officers for 2018", be deferred to the March meeting.

Director Turner introduced and welcomed Cyndi Gerlach, the Commission's new School District appointee.

II. Approval of the Agenda

V. Director's Recognition of Departing Commissioners

Director Turner stated that she wanted to take this opportunity to recognize the unique contributions of the departing Commissioners: Doug Green, James Heth and Allison Rzen.

Commissioner Green thanked Director Turner and NVRC staff.

VI. Director's Report

Director Turner highlighted a few items in her report:

- Cost-sharing: spoke to the meetings of the staff working group. A meeting between Director Turner and the two CAOs will be planned for late February; information will be shared with the Commission and both Councils thereafter. Director Turner added that if Commissioners require additional information, they can contact her directly.
- Parks and Recreation Management Software Project Update: NVRC, as well as 21 other municipalities, have selected PerfectMind as the provider. The goal is to launch the software at the end of this year/beginning of next year. Director Turner asked Cathy Matheson, Manager, Support Services to speak to recent discussions with the School Board. C. Matheson related that the School Board informed her they were exploring

other options for School District bookings, though she advised them that they can still join the collective purchase. Director Turner added that she discussed this with the new School District Superintendent when he began his new position, and she and Commissioner Gerlach had met on this as well. Commissioner Gerlach commented that she was open to exploring this further.

• Fitness, Health & Wellness Review: Director Turner stated that an update will be presented to the Commission in March.

A few questions were asked regarding the Before and After School Program, and the potential to expand it. Director Turner replied that staff will follow up on this.

VII. Items for Discussion/Decision

a) 2018 Arts and Culture Grants: Early Intake

John Rice, Cultural Services Officer, reviewed the intake process and policy requirements, spoke to items in the report and answered questions from the Commissioners, as did Director Turner.

THAT the Commission approves Arts & Culture grants as outlined in the report:

- (1) Grants totaling \$45,000 to support the new initiatives, special projects and annual programming of six arts groups ('Programming & Project Assistance Grants');
- (2) Grants totaling \$18,500 to support the production and promotion of one community event and one large-scale cultural festival ('Celebrations & Events Grants'); and
- (3) A 'Community Public Art' grant totaling \$7,000 to support a mural project in the District of North Vancouver.

Commissioner Gerlach provided her report. She spoke of the Handsworth Secondary replacement, as well as the School District's two new academies: Lacrosse at Carson Graham and Outdoor Education, for which they are looking to partner with "Power to Be".
