#### I. Call to Order

Chair Green called the meeting to order at 7:02 pm.

## IV. Delegation: North Vancouver Sports Council

Chair Green asked Director Turner to introduce the presenter; Director Turner introduced Bruce Tout who was presenting on behalf of the North Vancouver Sports Council Facility Needs Committee.

B. Tout thanked the Commissioners for the opportunity to present to them, and went through his PowerPoint presentation.

At the conclusion of the presentation, Chair Green asked the Commissioners for questions.

Commissioner Clark thanked B. Tout for the presentation, and asked for clarification on the curling and 52-meter pool needs.

Commissioner Porter commented on the use of artificial turf versus grass fields, and spoke to injury prevention. He asked B. Tout if the Sports Council evaluates safety in facilities. B. Tout replied that the Council acts more as an advisory body.

Director Turner asked B. Tout about the expressed need for three additional rinks as this has not come forward to date. B. Tout clarified that it is a 10-year outlook.

Commissioner Leia commented that injuries on artificial turf need to be considered. Director Turner stated that if Commissioners are interested, she will try to provide some data. Chair Green agreed and asked that it be presented at a future meeting.

Chair Green thanked B. Tout for his presentation.

#### V. Access & Inclusion Presentation

Director Turner introduced Janet Wallace, Community Recreation Coordinator (City Area) and Kelly Paus, Inclusion Programmer.

J. Wallace and K. Paus went through their PowerPoint presentation. Chair Green asked Commissioner for questions.

Following J. Wallace and K. Paus' answers to Commissioners' questions, Chair Green commented that the Commissioners are very supportive of inclusion initiatives.

Director Turner stated that NVRC is very fortunate to have two staff people dedicated to inclusion: J. Wallace, who is a long-standing employee and K. Paus who is a more recent employee who brings a heightened level of expertise.
